Member **Faylor** nominated himself for Vice Chair. Member **Bialy** seconded the motion. Motion carried 4-0.

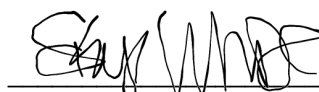
ADJOURNMENT:

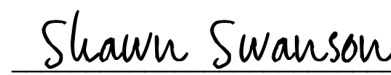
